PERSONAL GUARANTEE

Medley, without notice of any kind, may sell, assign, or transfer any of the Indebtedness to a third party, and in such event, each successive assignee, transferee or holder or any of the Indebtedness shall have the right to enforce this guaranty for the benefit of such assignee, transferee or holder. This guaranty shall be binding on the heirs, legal representatives, successors, and assigns of the undersigned and shall insure to the benefit of Medley, its successors and assigns.
